1. Entries will not be accepted without full payment of fees and signatures. No refunds after closing date. Post entries will be accepted if scheduling permits at twice the stated fee. No class changes will be made after the schedule is complete. Times will be posted on the club website and Facebook page.
2. All USDF Introductory and USEA tests will be ridden in the small arena. All others at discretion of management.
3. Informal Attire: Breeches and boots or half chaps. ASTM-SEI helmets required. Braiding not required. Boots, wraps, martingales, seat savers and side reins are prohibited and will result in elimination.
4. Awards will be ribbons to sixth-place per class (minimum of three entries per class required).
5. Tests may be called by a reader provided by the rider.
6. The show committee reserves the right to limit entries, to limit classes per horse, to provide additional judges, to add, divide or cancel classes or make whatever changes are required by the circumstances of the competition.
7. Neither the Erie Hunt and Saddle Club nor the show committee will be responsible for any damage, injury or loss to persons, horses or property of exhibitors or spectators.
8. The most current USDF, USEA and USEF tests will be used.
